

PORT BARRINGTON SHORES MARINA RULES AND REGULATIONS

1. The docking tracts in Port Barrington Shores are for the sole use of the respective Dock Owner/Renter, Dock Owner/Renter's immediate family, and their guests. Children must be under adult supervision at all times while on the premises.
2. Any dock owner who leases their tract must obtain a copy of these Rules and Regulations, and submit a copy, signed and dated by the lessee, to the Secretary of the Dock Association, for each season that the dock tract is leased.
3. Dock owner/Renter's automobiles must be parked in assigned areas only; two car's per docking space. Vehicles are restricted to the graveled areas only. Driving or parking on the grassy areas is prohibited. No parking is allowed in the restaurant parking lot
4. Trailers are not permitted inside the gate at any time. Any damage to the gate or surrounding property will be the responsibility of the Dock Owner/Renter. If a Dock Owner/Renter requires storage for a trailer or a boat, it is available thru Port Barrington Motor Sports.
5. The speed limit for motor vehicles at Port Barrington Shores Marina is 5 MPH. Please be concience to not create dust and be courteous to our neighbors
6. The channel and surrounding waters, not including the river, is NO WAKE.
7. Shore Station CANOPIES must be WHITE or GREY
8. Pets are welcomed at Port Barrington Shores subject to the following conditions:
 - .All pets must be leashed at all times
 - .Pets may not be tied or chained to any trees or equipment.
 - .Excessive noise or disturbance on the part of the pet will cause the pet to be barred from the premises
 - .It is the pet owner's duty to clean up after the pet
 - .Pet owner's agree to financial responsibility for any and all damage caused by the pet
9. No lawn furniture, barbeques, etc. are to be placed or stored on the docks, walkways, or in front of your boat. Barbeque areas are designated around the gazebos. Approved dock boxes are allowed. They are available through Port Barrington Motor Sports. All dock boxes must be permanently mounted and secured for safety purposes. Management will remove non-approved dock boxes.
10. All piers have water and electric. The electric utilizes a standard marine grade twistlock plug. Boat owners are responsible for supplying their own cord. Each pedestal has its own electric metering device. Management has established a standard whereby to measure excessive electric consumption. If a boater has excessively high demand for power, they will be billed for the additional usage.

Water is to be used for rinsing the boat and domestic purposes. No car washing is permitted. Absolutely no modifications are to be made to the pedestal to accommodate specific needs. If you require special electrical hookup, advise management and arrangements will be made through our electrical contractor. The cost of any modifications will be borne by the Dock Owner.

11. Swimming and fishing are not permitted around the river piers or in the channel.
12. Dock Owners, their families, and guests are requested to refrain from making excessive noise. Management reserves the right to remove any objectionable person or persons who cause a disturbance or become a nuisance.
13. FUELING OF VESSELS ANYWHERE WITHIN THE MARINA IS STRICTLY PROHIBITED. Due to spill recovery plans, fire suppression, and proper grounding, this provision will be strictly enforced and immediate termination of the lease will result.
14. No running, jumping from, hanging from, or fishing from the bridge. Management asks that everyone keep an extra sharp vigil on children using the bridge.
15. All piers at Port Barrington Shores are intended for the use of one vessel per pier. Personal watercraft, rowboats, dinghies, paddle boats etc. are not to be tied or left in the slip, behind, next to, or in front of the designated vessel.
16. A dumpster is provided for the Dock Owners and is located in the Marina parking lot. Please be sure to discard all trash properly before you leave the Marina.
17. The use of carpeting, tires, fire hose etc. as boat bumpers is strictly prohibited. Bumpers specifically manufactured for this purpose may be used.

PLEASE HAVE A SAFE AND HAPPY BOATING SEASON

I have read and will abide by the above Rules and Regulations. Failure to do so will result in the immediate termination of my lease and the forfeiture of all monies paid.
